10. RATE:

The price (along with 1 year's Comprehensive onsite Warranty of entire Items from the date of purchase) is to be quoted in Indian Rupees. (Project rate must be coated after careful calculation of all/total no of material.)

The basic rate should be furnished **inclusive of all taxes duties & charges** e.g. Customs Duty, Transportation Cost, Insurance, Freight, Testing charges, Incidental Charges etc. but excluding of GST, Excise Duty, Entry Tax & Cess etc. which shall be quoted separately in the template for Bill of Quantities (BOQ). Percentage of GSTis to be mentioned in the appropriate Column of the template for Bill of Quantities. *The Final Price should be calculated/bid including Installation charge, Carriage charge or any other charge. No hidden charge in addition to bid amount will be paid. For completion of the project bidders must have to make required demonstration. The Items are to be transported in such a manner so that there is no damage to the Items.*
